(2) No residence shall be erected on said lot costing less than \$2,000.00. (3) This lot shall be used for residential purposes only and shall not be sundivided so as to

face in any direction other than as shown on the plat thereof referred to herein.

(4) This lot shall never be sold, rented or otherwise disposed of to persons of African descent.

It is understood that the Grantee assumes the balance remaining due on account of paving assessments assessed by the City of Greenville against the above described property. X
