the Village of Travelers Rest, in the County and State aforesaid, and a short distance to the
West of the Tubbs Mountain Road on an unnamed street running from the said Tubbs Mountain Road
westward through property of the Love Estates. The particular lot of land which is here being
conveyed is known and designated as Lot No. 70-E on a revised plat of the "Love Estates", which
said plat is recorded in the office of the R. M. C. for Greenville County in Plat Book K at page
31, and contains 11 acres, more or less, and described by courses and distances on this said plat
as follows, to-wit:
Beginning on the aforementioned unnamed street at joint corners of Lot No. 70-E on the aforementioned revised plat and Lot No. 48 on another plat of the "Love Estates" which is recorded
in the office of the R. M. C. for Greenville County in Plat Book I at pages 111 and 112, and runn-
ing thence along the rear lines of lots 48 to 54 inclusive N. 2-00 E. 721.5 feet to corner on
Southerlin; thence S. 79-30 W. 488 feet to corner; thence S. 40-30 W. 434.7 feet to corner on
A. L. Henderson; thence S. 36-21 E. 679 feet to corner on the unnamed street; thence along said

tions and reservations as follows, to-wit:

African descent for a period of Twenty (20) years from this date, except that a servant's house
or houses may be erected there on for the use of colored servants or tenants employed on the
premises.
(2) No house, unless it be a servant's house, shall be erected on said premises within
300 feet of the unnamed street of a value of less than \$1,000.00. And any such house so erected
shall within three (3) months of its completion be painted, if it be constructed of wood.
It is understood and agreed that the aforementioned restrictions and reservations are
to run with the land and are for the protection of the grantors and any grantee of lands in the
said sub-division or the other sub-division of the "Love Estates" Plat which is recorded in the
office of the R. M. C. for Greenville County in Plat Book I at page 111. And the owner of any
property in the said sub-division shall have the right to enforce the said reservations and con-
ditions by appropriate action.
