TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA,

GREENVILLE COUNTY.

THIS AGREEMENT made the 26 day of September, 1940, between J. E. Sirrine, hereinafter designated as "Sirrine", and Adelaide B. Arrington, hereinafter designated as "Mrs. Arrington", both residents of Greenville, in said County and State.

WHEREAS Sirrine owns a lot of land at Caesar's Head in said County and Mrs. Arrington has an adjoining lot, and she desires permission to cross and pass over the land of Sirrine, with the understanding that it may be revoked at his option, and that of his heirs and assigns, it has been agreed as follows:

That Sirrine has given to Mrs. Arrington from date to day, until this license is terminated, a right of way over his lot from her lot to South Side Drive, such right of way to be a place to be designated and at no other point. Sirrine's lot is No. 12, on plat of Dalton & Neves of the Caesar's Head property, in Plat Book "G" at page 123. The lot of Mrs. Arrington is No. 14. It adjoins No. 12 and faces on Sunrise Drive.

It is specifically agreed that this is a temporary license. At any time Sirrine and his heirs and assigns shall have the right to terminate the license immediately and cancel this temporary use. The means of effecting cancellation shall be, either by a letter addressed to Mrs. Arrington at her residence in the City of Greenville and deposited in the postoffice with the postage paid, or written notice delivered to her, signed by Sirrine or his heirs and assigns. No other form of notice shall be necessary.

Mrs. Arrington accepts the terms of the above license and especially agrees as follows:

That she will only cross Sirrine's land at the place designated by him; that no unreasonable use shall be made of the license; that no cars shall be parked or left upon Sirrine's
land. That upon receipt of a letter terminating the license she will immediately refrain from
further entry upon Sirrine's lot and will not thereafter use the same for any of the purposes
specified herein.
