C., as Trustee, has agreed to said conveyance and has agreed to look to the premises comered by its mortgage as the sole security for its debt and is willing for the said John T. Davenport to make said conveyance and be discharged from all liability to it under the terms of said trust deed;

NOW, THEREFORE, KNOWN ALL MEN BY THESE PRESENTS, That I, John T. Davenport, Assignee and Trustee of Marion B. Leach, deceased, in the State aforesaid, in consideration of the premises and the sum of Five Dollars to me in hand paid by Marion B. Leach, Dorothy A. Leach and Elizabeth Leach Bogle, in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Marion R. Leach, Doroty A. Leach and Elizabeth Leach Bogle- All of those certain pieces, parcels or lots of land in Greenville Township, State and County aforesaid, and more particularly described as follows:

- (1) Lot approximately 60 ft. X 248 ft. on the North side of Augusta Road, just beyond the corporate limits of the City of Greenville, conveyed to Marion B. Leach by J. F. Welborn by deed dated December 22, 1919, and recorded in office of R. M. C. for Greenville County in Deed Book 54 at page 299.
- (2) Lot on Means Street in the City of Greenville, South Carolina, fronting 69 ft. on the West side of said Street and being approximately 150 ft. deep, conveyed to Marion B. Leach by W. F. Blassingame by deed dated January 7, 1897, recorded in Deed Book CCC at page 568.
