shall be erected thereon prior to January 1, 1986.
3. No surface closet or cesspool shall ever be used on said lot, but only septic tanks or other
similar sewers.
4. The lot shall not be recut and only one dwelling erected thereon.
5. No house shall be erected on this lot less than 30 feet from the Highway line.
The foregoing conditions are not conditions subsequent but are to be deemed covenants running
with the land and binding on all owners and occupants thereof.
