Slater & Sons, Inc., in and near the village of Slater, and heretofore used for serving said mill village, said electric distribution lines and system being shown approximately by red lines on print hereto attached and made a part hereof; including all poles, wires, substation transformers, distribution transformers, guy wires, cross-arms, insulators and all other property constituting said electric distribution lines and system; Excepting, however, from the operation of this instrument, the street lighting circuits, lamps and fixtures and such poles as are used exclusively for maintaining and operating said street lighting circuits.

And for the consideration above set out, the said S. Slater & Sons, Inc., does hereby grant, sell and convey to Duke Power Company, its successors and assigns, the right, privilege and easement over, upon and across the lands, streets and ways in said mill village, of maintaining, operating and using said electric lines and system as same are now located and constructed, and such lines as hereafter may be located and constructed by Duke Power Company, its successors and assigns, along the streets, alleys, roads or ways shown on the above mentioned print.
