All that piece, parcel or lot of land in Greenville Township, and Greenville County, State of South Carolina, about two and one-half miles north of the City of Greenville, in the subdivision known as Mountain View, said lot being designated as Lot No. 79 of Block "C" as shown on a plat of same recorded in the R. M. C. Office for Greenville County, in Plat Book "A", at pages 396 and 397, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Bailey Street, at the joint corner of Lot No. 80, and running thence N. $89\frac{1}{2}$ W. 148 feet to a pin on a ten-foot alley; thence along the line of said alley S. $11\frac{1}{2}$ E. 50 feet to an iron pin; thence S. $89\frac{1}{2}$ E. 148 feet to an iron pin on Bailey Street; thence along Bailey Street N. $11\frac{1}{2}$ W. 50 feet to the beginning corner, and being the same lot of land conveyed to Idona Westbrook and Pammie Westbrook by R.
