"All that certain piece, parcel and lot of land lying and being situate in the County
and State aforesaid, on the northern boundary of the village of Travelers Rest, and being known
and designated as Lot No. 32 on a revised plat of "Love Estates", which said plat is recorded
in the office of the R. M. C. for Greenville County in Plat Book K at page 31, and being more
specifically described by courses and distances as follows, to-wit:- Beginning at the north-
eastern intersection of a new cut street and a road leading from the Buncombe Road into the
business section of Travelers Rest and running thence along the last named road N. 64 E. 100
feet to corner on lot No. 33 in said sub-division; thence along the joint line of lots 32 and
33 N. 25-41 W. 200 feet to a corner on rear line of lot No. 58; thence S. 64 W. 100 feet to the
new cut street first above mentioned; thence along the eastern side of said new cut street S.
25-41 E. 200 feet to the beginning corner.
Also all that other piece, parcel and lot of land adjoining the above described lot
on the north thereof and being known and designated as Lot No. 57 in the above mentioned sub-
division. It is also in the County and State aforesaid and just north of the village of Travel
Rest. It lies in a right angle of two new cut streets and is described on the aforementioned
plat by courses and distances as follows, to-wit:- Beginning in the southern right angle of the two new cut streets and running thence S. 25-41 E. 200 feet along the eastern side of one of the
new cut streets to the rear boundary of lot No. 32; thence along joint line of lots 32 and 57 N
64 E. 90 feet to corner; thence along the joint line of 57 and 58 N. 25-41 W. 200 feet to the

It is understood and agreed that the aforedescribed lots are conveyed subject to
certain reservations and restrictions which are as follows, to-wit:-
As to both lots:
(1) No portion of the aforementioned lots shall be rented or sold to any person of
African descent for a period of Twenty (20) years from this date, except that a servant's house
or houses may be erected thereon for the use of servants employed on the premises.
(2) For a period of Ten (10) years from the date of this conveyance no portion of the
said property shall be used for any business purposes.
As to lot No. 32 only:-
(1) No residence (except for private garages and out buildings) shall be constructed
said property of less value than Two Thousand (\$2,000.00) Dollars, exclusive of the lot value.
As to lot No. 57 only:-
(1) No house, unless it be a servant's house, shall be erected on said premises of a value of less than One Thousand (\$1,000.00) Dollars and any such house so erected shall within
Three (3) months of its completion be painted, if it be constructed of wood.
It is understood and agreed that the aforementioned restrictions, conditions and re-
servations are to run with the land and are for the protection of the grantors and any grantees
of lands in the said sub-division, or in another sub-division of the "Love Estates" which is
recorded in the office of the R.M.C. for Greenville County in Plat Book I at page 111. And the
owner of any property in the said sub-division shall have the right to enforce the said reserva-
tions and restrictions by appropriate action.
