## LEASE

AGREEMENT dated the 6th. day of January, 1:41, by and between Mr. R. L. Ford, Greer, South Carolina, (lessor) and THE TEXAS COMPANY, a corporation of Poleware, having a place of business at Houston, Texas (lessee).

(1)- PREMISES IRASED. Lessor hereby leases unto lessee a tract of land, with the improvements thereon, in the City of Greer, County of Greenville, State of South Carolina, described as follows:

Beginning at a point on the north side of U. S. Highway # 29,47 feet west of the northwest corner of the intersection of U. S. Highway # 29 and Forest Street and running west, along the north side of U. S. Highway # 29, 100 feet to a point; thence north 100 feet to a point on the south side of Reese Street; thence along the south side of Reese Street in a southeasterly direction 60 feet to a point; thence in a southeasterly direction 88 feet to the point of be-

Together with all right, title, and interest of lessor in and to any and all roads, streets and ways bounding the said premices:

Together with the buildings, improvements, fixtures, equipment and facilities of the lessor now located on said premises as follows:

- 1- 18'  $\times$  18' Brick service station building with 18'  $\times$  22' Canopy with paved driveway under  $\otimes$  canopy-building complete with men's and ladies rest rooms.
- (2)-TERM. TO HAVE AND TO HOLD for the term of FIVE (5) years, from and after the First day of February, Nineteen Hundred Forty-one (Feb. 1, 1941) but subject to termination by leasee at the end of the first year or any subsequent year upon thirty (30) days written notice from lessee to lessor.
  - (3) RENTAL- Lessee agrees to pay the following rent for said premises:

TWENTY DOLLARS (\$20,00) per month, payable on or before the 10th. day of each month next following the month for which payment is made. It is understood however, that for each year of the term hereof in which more than 24,000 gallons of lessee's gasoline shall be sold from the leased premises, lessee shall pay, within thirty days after the expiration of such year, an additional sum equal to one-cent (lg) for each gallon of its gasoline so sold in excess of 24,000 gallons; to provided, that if this lease is terminated prior to the expiration of any contract year, then the additional rental, if any shall be a sum equal to one-cent for each gallon of lessee's gasoline sold in excess of that quantity which bears the same ratio or proportion to 24,000 gallons; to lone as the expired portion of such contract year bears to the whole year, and provided further that the rental for any one contract year during the term of this lease shall not exceed \$480.00 and agrees that, if any installment thereof shall be due and unpaid for ten (10) days after written notice of such default has been delivered to the Assistant Land Attermey of the Lessee at Houston, Texas lessor shall then have the right to terminate this lease of thirty (30) days' written notice to lessee.

Lessee, at its option, may apply at any time such rental or any installment thereof to the payment of any indebtedness due or to become due from Lessor to Lessee. Such application shall be deemed payment of such rental.

No change in ownership of the premises, or assignment of the rental provided for herein, shall be binding upon lessee for any purpose until after lessee has been furnished with a written transfer or assignment, or a true copy thereof, evidencing such change in ownership or assign-

- (4) MAINTENANCE- Lessor agrees to maintain said premises and improvements, including plumbing, heating, and electric wiring, in good repair, and to paint same when deemed necessary in the opinion of the lessee during the term of this lease, and to re-build within sixty (60) days any structure on said premises damaged or destroyed in any manner. In the event of lessor's failure to do so, lessee, at its election, may either terminate the lease on thirty (30) days' notice to lessor, in which event rental shall abate from the date of destruction or demage, or do the necessary repairing or rebuilding at the expense of the lessor, and have the right to apply accruing rentals for the purpose of reimbursing itself for the principal expenditure, together with interest at six per cent. If, during the time the premises are undergoing repairs, the use thereof by lessee is materially interfered with, the rent accruing during such period shall be abated. shall be abated.
- (5) REMOVAL OF PROPERTY. Lesse shall have the right at any time during the continuance of this lesse or within thirty (30) days after its termination to sever and remove all buildings, and improvements, fixtures, equipment and other preperty owned by lessee or placed on said premises by lessee during the term of this or any previous lease, or any extension or renewal thereof.
- (6) IESSEE'S RIGHT OF TERMINATION- Should lesses, for any reason other than (a) any wilful act of lesses and/or (b) damage or destruction of premises and/or any structures thereon, be prevented from establishing or continuing the buliness of distributing petroleum products on said premises, lesses may terminate this lesse upon giving thirty(30) days!written notice to lessor, in which event the rental obligation shall be provated to the date of such termination.
- (7) DAMAGES FOR DEFECT IN TITLE. Lessor covenants that he is well seized of said premises, has good right to lease the same, and warrants and agrees to defend the title thereto, and to reimburse and hold lessee harmless from all damages and expenses which lessee may suffer by reason of any restriction, encumbrance or defect in such title.
- (8) TAXES AND ENCURBRANCES- Lessor agrees to pay all taxes, assessments and obligations which are or may become a lien on the domised premises and improvements as they become due. If lessor should fail to do so, lessee shall have the right either to make such payments for the account of lessor, in which event it shall be subregated to all the rights of the holder of such lien, and in addition thereto shall have the right to apply account greaters in satisfaction of such obligations: or lessee, in the event of a foreclosure of any such lien and the sale of said
