

## TITLE TO REAL ESTATE-G.T. 202

the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said P. A. McBride, Jr., and H. E. Jetor, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the south side of Ackley Street, and being known and designated as Lot Number 1, as shown on plat thereto made for J. G. Oely, August, 1939, by J. Coke Smith, and being more particularly described as follows, to-wit:

Beginning at an iron pin on the south side of Ackley Street, at the joint corner of Lots Nos. 1 and 2, which point is approximately 335 feet northeast from the southeast corner of the intersection of a 40-foot street known as Coland Street, and Ackley Street, and running thence along the line of Ackley Street, N. 65-15 E. 75 feet to an iron pin; thence S. 36-05 E. 200 feet to an iron pin, joint rear corner of Lots Nos. 1 and 10; thence along the rear line of Lots 10 and 9, S. 54-00 W. 100 feet to an iron pin, joint rear corner of Lots Nos. 1 and 2 in line of Lot No. 9; thence along the joint line of said Lots 1 and 2, approximately N. 32 W. 222 feet to the beginning corner.
