at the intersection of Super Highway #29 and Lee Road, being triangular in shape, and having according to Survey and plat made by R. E. Dalton in June 1941, the following courses and distances to-wits:

Beginning at a pin in the Northwest Intersection of Super Highway No. 29 and the Lee Road and running thence along the Southern side of Lee Road S. 74 W. 400 feet to stake; thence continuing with said road S. 74-21 W. 327 feet to a stake on the Eastern side of 20 foot road; thence with the eastern side of said 20 foot road S. 20-20 E. 28 $\frac{1}{2}$ feet to stake; thence continuing with said 20 foot road S. 12-28 E. 147.2 feet to a stake on Northern side of Super Highway #29; thence with the Northern side of said Super Highway #29 N. 45 E. 833 feet to the point of beginning.
