Minnie Lee Swift and her heirs and assigns forever;All that piece, parcel or lot of land in Chicks Springs, Township, Greenville County, State of South Carolina

lying on the South side of James Street and on the East side of South Main Street, near the incorporate limits of the Town of Greer, and being all of lots Nos. 1 and 2 on a plat of a sub-division known as "Cannon Park", which plat is recorded in the R. M. C. office for Greenville County in Plat Book F, at page 195, reference to which plat is hereby made for a more definite and particular description of said lots. Said lots are bounded on the North by James Street, on the East by lands of Raymond White, on the South by an alley and W. Lyle Black, and on the West by South Main Street. Said lots have the following courses and distances according to said plat.

Beginning at a point, corner of S. Main Street and James Street, and running thence along the edge of James Street S. 83.30 E. 120 feet to the corner of lot No. 3, or Raymond White's corner; thence along the line of lot No. 3 197.3 feet to alley; thence along the line of said alley N. 76.30 W. 113.5 feet to a point; thence N. 6.15 E. 188.5 feet to the beginning.
