All that certain piece, parcel and tract of land in the State and County aforesaid in the City of Greenville, South Carolina being more fully described as follows:

Beginning at an iron pin on Newman Street 174.1 feet from the northeastern intersection of McDaniel Avenue and Newman Street and running thence in line with McDaniel Avenue across Newman Street to the line of Mrs. Alden Simpson's property, southern side of Newman Street, thence along the southern side of Newman Street crossing Belmont Avenue to an iron pin at the corner of lot number 58 according to a plat made by Dalton & Neeves, April 1941 which said pin is at the southeastern intersection of Belmont Avenue and Newman Street; thence in an eastern direction along the front line of lots 58, 57, 56, 55, 54, 53, 52, 51, 50 to an iron pin corner of lot number 50 which said corner is at the intersection of Newman Street and Austin Street; thence in a northwestern direction across Newman Street to a point in front line of lot number 74; thence along the front lines of lots number 74, 73, 72, 71, 70, 69 and crossing Belmont Avenue along the northern side of Newman Street to the point of beginning.

Also all that other piece, parcel and tract of land in the City of Greenville, South Carolina, being more fully described as follows:

Beginning at an iron pin at the corner of lot number 59 according to the above referred to plat which said pin is at the northwestern intersection of Belmont Avenue and Newman Street and running thence along the front line of lots 59 to 63 inclusive; thence along the northern side of lot 63 in a straight line to an iron pin on McDaniel Avenue; thence along McDaniel Avenue in a northern direction to an iron pin corner of Dr. L. H. McCalla's lot; thence in an eastern direction to an iron pin in front line of lot number 64; thence along the front line of lots 64 to 69 inclusive to an iron pin in the northern side of Newman Street; thence crossing Belmont Avenue in a western direction to the point of beginning.
