CONTRACT

This Contract made and entered into by and between J. M. Waddell and J. A. Foster, hereinafter referred to as the Sellers, and Thomas F. Allsep, hereinafter referred to as the purchaser:

## WITNESSETH:

That in and for the consideration hereinafter expressed the sellers agree to sell and convey unto the purchaser, that certain property situate near the City of Greenville, in the County of Greenville, State of South Carolina, known as Lots #79 and 80 according to a plat of the subdivision known as Morgan Hill, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book "A" at page 70, and being the same property conveyed to the sellers herein by Charles Lee Holcombe, said deed being recorded in the R. M. C. Office for Greenville County in Mortgage Book 220 at page 293, upon said purchaser complying with all the terms and conditions hereinafter set forth.
