Ashmore, Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of twenty nine & 58/100 Dollars to me paid by the said grantee (s), The Forfeited Land Commission have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee(s), The Forfeited Land Commission their assigns or successors:

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said Forfeited Land Commission their assigns, or successors, forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
