TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

All that certain piece, parcel or tract of land situate, lying and being in Butler Township, Greenville County, State of South Carolina, about four miles from Greenville, on the Congaree Road, containing three and eight one-hundredths (3.08) acres, to be the same more or less, and being a part of Tract Number Eight (8) in the subdivision of the C. R. Bramlett farm according to plat prepared by W. J. Riddle, Surveyor, on March 23, 1937, and being a part of tract Number Eight-B (8-B) of said division according to resurvey and plats prepared by W. J. Riddle, July 15, 1940, and August 8, 1941, and being more particularly described as follows:
