To Have and to hold, all and singular, the properties, whether real, personal, or mixed, herein conveyed and transferred to Second Party, its successors and assigns forever, in fee simple, with covenant of general warranty.

The First Party hereby covenants and binds itself, its successors and assigns, to warrant and forever defend the right and title to each and all of said properties herein conveyed to Second Party, its successors and assigns, against the claims of all persons whomsoever.

S. Whitney Landon, being first duly sworn, states as follows:

That he is the President of the American Telephone and Telegraph Company of South Carolina, which is the grantor in the transaction hereinafter referred to, and that he is thoroughly familiar with all the facts connected with said transaction.

That, by a deed dated December 18, 1941, the American Telephone and Telegraph Company of South Carolina transferred to its sole stockholder, the American Telephone and Telegraph Company, all its property, assets, rights, and privileges in the State of South Carolina, and more particularly all its property in the County of Greenville in said State.

That the transfer of said property was made pursuant to a vote of the stockholders providing for the dissolution of the American Telephone and Telegraph Company of South Carolina and distribution of allits property in kind to the American Telephone and Telegraph Company upon the surrender and cancellation of all the outstanding capital stock of the American Telephone and Telegraph Company of South Carolina, and the assumption of the American Telephone and Telegraph
