TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

KNOW ALL MEN BY THESE PRESENTS: I, Cary E. J. Riddle, August 22, 1941, described as follows:

Beginning at McDaniel corner on said Buncombe Road, and running thence with McDaniel line, S. 74-30 W. 1415 feet to a pin on line of lot No. 2; thence with the line of lot No. 2, S. 60 W. 1331 feet to Buncombe Road; thence with Buncombe Road, N. 36-30 W. 350 feet to Buncombe -Read; -thence-with-Buncombe-Road; -N:-36-36-W:-350-feet-to the beginning corner.

and executed and deliver a good and sufficient warranty deed therefor on condition that the said Joe Williams and Tom Reid shall pay the sum of Two Hundred Fifty (\$250.00) Dollars in the following manner Eighty Dollars (\$80.00) cash, receipt of which is hereby acknowledged, and the balance in monthly installments of Ten Dollars (\$10.00) each, first payment of \$10 to be made April 14, 1942, and thereafter \$10 on the 14th day of each succeeding month

until the full purchase price is paid, with interest on same from date at six per cent. per annum until paid to be computed and paid quarterly, and if unpaid to bear interest until paid at same rate as principal, and in case said sum or any part thereof be collected by collected by an attorney, or through legal proceedings of any kind, then in addition the sum of Twenty-five (\$25.00) dollars for attorney's fees, as is shown by note of even date here with. The purchaser agrees to pay all taxes which this contract is of force.

It is agreed that time is of the essence of this contract, and if the said payments are not made when due I shall be discharged in law and equity from all liability to made said deed, and may treat said Joe Williams and Tom Reid as tenants holding over after termination, or contray to the terms of their lease, and shall be entitled to claim and recover, or retain if already paid the sum of Twenty-five (\$25.00) dollars per year for rent, or by way of liquidated damages, or may enforce payment of said note.
