Cahill, First Assistant Commissioner, (hereinafter referred to as "Grantor"), for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release, unto J. B. Rada and Magnolia Y. Rada, of 406 E. Washington Road, Greenville, South Carolina, their heirs and assigns, (hereinafter referred to as "Grantees"):

All that piece, parcel or lot of land in Greenville County, State of South Carolina, known and designated as Lot No. 16, of Anderson Street Highlands, according to a plat thereof made by Dalton and Neves, Engineers, in 1939, recorded in the R. M. C. Office for Greenville County in Plat Book "J", page 157, and having according to said plat the following metes and bounds:
