TITLE TO REAL ESTATE

WHEREAS, R. N. Smith County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembley of South Carolina and the statute laws of said State, against Dr. O. Ashmore the then delinquent tax collector of the State and County aforesaid, did on the 9th day of November, 1937 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of Dec. during the usual hours of sale, after due advertisement, sell the same to The Forfeited Land Commission and their and assigns, or successors the purchasers, hereinafter known as "grantees", and the highest bidder at such sale, for the sum of seventy seven & 70/100 dollars and gave a receipt for said purchase money to them; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer, or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, M. L. Ashmore Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of seventy seven & 70/100 dollars Dollars to me paid by the said grantees, The Forfeited Land Commission have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantees, The Forfeited Land Commission their and assigns, or successors:

All that lot, piece or parcel of land known as lot number 942, 943, 797, 798, 799, 800, 801 of the Tryon Development Company land known as Lake Lanier. For a more particular description see deed of Tryon Development Co. to Dr. O. L. Bruorton recorded in R. M. C. Office for Greenville County in Vol. 170, pages 41 & 42.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO Have and to Hold all and singular the premises hereby granted, with the appurtenances, unto the said Forfeited Land Commission their assigns or successors forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
