TITLE TO REAL ESTATE

## RIGHT-OF-WAY GRANT

RECEIVED OF POSTAL TELEGRAPH-CABLE COMPANY -----Eighty and no/100 Dollars, in consideration of which I (we) hereby grant and convey unto said Company, its associated and allied companies, their respective successors, assigns, lessees and agents, a perpetual right of way and easement to construct, reconstruct, operate, repair, relocate and maintain lines of telegraph and telephone, consisting of such poles, wires, cables, cross-arms, conduits, guys, guy stubs, anchors and other fixtures and appurtenances as said grantee may from time to time require, upon, across over and/or under the property owned by me (us) in the City (Town) of East Gentt Township. County of Greenville, and State of South Carolina, more fully described in deed dated March 6, 1937, recorded in the office of the Recorder of Deeds (or Clerk) of Greenville, County, State of South Carolina, in Book 192, page No. 125, and upon, along, over and/or under the roads, streets or highways adjoining the said property, together with the right of ingress thereto and egress therefrom across adjacent lands owned by me (us) for the purpose of constructing, repairing, renewing, changing and operating said lines, and also the right to trim from time to time any trees along said lines so as to keep the wires and cables cleared at least thirty-six inches on all sides, and the right to cut all underbrush under the line to a distance of at least ten feet each side from the center line of the poles, and the right to permit the attachment on its poles -of/or carry in conduit the wires, cables, cross-arms and fixtures of any other company. The grant or (s) for himself (themselves) his (their) heirs, executors, administrators and assigns hereby covenant(s) that no inflammable structure shall be erected or permitted on said property within 50 feet of said lines. Said sum is received in full payment for the rights herein granted, which without the concurrence or approval of anyone else, I (we) have good right to grant. poles or facilities as are erected hereunder, or as may hereafter be erected, within the limits of any hgiway may without further consideration be relocated to conform to new or reestablished Fruit Trees and Shrubbery to be undisturbed unless within 2 ft. of wires. Poles to be located 5: from Joint boundary J. F. Blackmon & F. M. Shockley Lands. 125' from Old U. S. Highway 25 and running approximately 470' N. 84-20 W. -thence 5' from Railroad right-of-way approximately 1200' S. 6-54- W. to intersection of conestee Road.
