TITLE TO REAL ESTATE

Right of peaceable entry, right of way and easement at all times for the purpose of surveying, building, operating, maintaining, improving and repairing a railroad spur track from the C. & G. Line near Gantt Station to the Army Air Base on the Augusta Road, upon, along and over that certain belt, strip or right of way 70 feet in width upon which said spur track has already been completed and is now in operation, extending upon, along, over, through and across that tract of land containing 26 acres belonging to the grantor and situate in said county and state aforesaid and more particularly described as follows:

All that certain piece, parcel or tract of land in Gantt Township, County and State aforesaid containing 26 acres, more or less, being the same property conveyed to the within grantor by Virginia Myers and Emmie Batson by deed dated March 10th, 1898, recorded in the Greenville County R.
