Deal and Melvin Deal, hereinafter designated as "Purchaser" a certain lot or tract of landin the City and County of Greenville, State of South Carolina, on the South side of West Washington Street described as follows: BEGINNING at a point on the South side of West Washington Street, which point is 235.1 feet west of the intersection of Washington and Westfield Streets and running thence S. 23-30 W. 217.5 feet to an iron pin; thence N. 66-30 W. 80 feet to an iron pin; thence N. 23-30 E. 217.5 feet to an iron pin on the South side of West Washington Street; thence with the South side of West Washington Street S. 66-30 E. 80 feet to the point of beginning.

This being the same property conveyed to W. G. Sirrine by the First National Bank of Greenville, S. C., on January 8, 1942. Deed recorded in Volume 241, page 183, R. M. C. office for Greenville County, S. C. When purchasers have paid one-half the purchase price they shall receive a deed free of all encumbrances and shall give a first mortgage of the premises for the balance of the purchase price, payable on same terms as contract, and execute and deliver a good and sufficient warranty deed therefor on condition that he shall pay the sum of Six Thousand Five Hundred and no/100 Dollars in the following manner One Hundred (\$100) cash and the remainder Sixty (\$60) Dollars per month, due and payable on the first day of each calendar month beginning October 1st, 1942, until the full purchase price is paid, with interest on same from date at six percent per annum until paid, to be computed and paid annually in advance and if unpaid to bear interest until paid at the same rate as principal, and in case said sum or any part thereof be collected by an attorney, or through legal proceedings of any kind, then in addition the sum of five per cent for attorney's fees, as in shown by his note of even date herewith.
