Line near Gantt Station to the Army Air Base on the Augusta Road, upon, along, and over that certain belt, strip or right of way 70 feet in width upon which said spur track has already been completed and is now in operation, extending upon, along, over, through and across that tract of land containing 24.64 acres, belonging to the grantor and situate in said County and State aforesaid and being more particularly described as follows:

All that certain piece, parcel or tract of land situate in Gantt Township, County and State aforesaid, containing 24.64 acres, more or less, being the same property as that conveyed to Louise Earle by J.
