All that certain lot of land conveyed to American Land & Investment Company by J. P. McLeod on or about November 12, 1937, by deed duly recorded in office of R. M. C., County of Greenville, in Deed Book 200, at page 429, and therein more fully described as follows:

and County aforesaid, in the City of Greenville, on the west side of Hammond Street, being known and designated as Lot No. 15 on Plat of the McBee Land, recorded in Deed Book ZZ, at page 482, in the R. M. C. Office for the State and County aforesaid, and having, according to such plat, the following metes and bounds, to-wit:
