Ricketts, Trustee, the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said J. B. Ricketts, Trustee,

Parcel No. 1. "All that piece, parcel or lot of land in Oak Lawn Township, Greenville County, State of South Carolina, on the Augusta Road, about 5 miles from the town of Pelzer, containing 104 acres, more or less, and being composed of two tracts of land as follows:

- (a) One tract containing 14 acres of land, more or less, and described as follows: Beginning at a stone and running thence S. $86\frac{1}{2}$ W. 10.36 chains on the public road leading from J. E.
