commence on the property hereinbefore described within One Hundred Twenty (120) days after the signing and delivering of this instrument, and that the Party of the Second Part will operate said mine regularly unless prevented by acts of God, acts of government, or other unavoidable circumstances; and in the event said Party of the Second Part fails to commence operations on said premises within said period hereinbefore mentioned, or is unable at any time, for any cause, to continue said operations as hereinbefore provided, then this lease may be continued in full force and effect only by payment to the Parties of the First Part by the Party of the Second Part the sum of Ten (\$10.00) Dollars per month as minumum royalty in the manner hereinbefore described for said royalty payments; provided, however, that failure by the Party of the Second Part to make said minumum royalty payments shall constitute good and valid cause for the Party of the First Part to cancel this lease without further notice, except, however, that any royalty payments in excess of Ten (\$10.00) Dollars in any calendar month shall be construed as having fulfilled all for the month in which said larger sum is paid and also for such next consecutive months for conditions of payment for said Ten (\$10.00) Dollars per month minimum royalty/could normally be paid as hereinbefore provided, with a sum equivalent to the balance above Ten (\$10.00) Dollars in such months in which said royalty payments are in excess thereof, whereupon the further payment of said minimum royalty shall continue upon the terms hereinbefore provided.

It is agreed by the Party of the Second Part that no unnecessary damage shall be done the lands hereinbefore described; that all mining operations on said lands will be carried on in a workmanlike manner such as a reasonable miner would do, and that the premises under this lease will be surrendered at the expiration of this lease or any extension thereof in as good and clean condition as the reasonable requirements of the mining herein provided for permit.
