NOW THEREFORE, in consideration of the above, the Augusta Road Telephone Company

Inc. does hereby relinquish, surrender, transfer, release, and quit-claim to the United States of America, and its assigns, all its rights, title and interest in and to property which the Augusta Road Telephone Company, Inc., holds under grants of right-of-way, easements or other evidence of
