## TITLE TO REAL ESTATE

## BY THE SECRETARY OF STATE

WHEREAS, Georgie Schell, Lola Gary, Ophelia Meekins, L. T. Robertson and Raymond Barton, did on the 31st day of December, 1942, file with the Secretary of State a written Declaration, signed by themselves, setting forth:

First: That their names and residences are as above given.

Second: That the name of the proposed corporation is BRUTENTOWN CO-OPERATIVE LAUNDRY ASSOCIATION

Third: That the principal place of business is Greenville, S. C.

Fourth: That the general nature of the business which it is proposed to do is Conduct a cooperative laundry and other co-operative community developments.

Fifth: That the amount of the capital stock is Two Hundred (\$200.00) dollars, payable Cash

Sixth: That the number of shares into which the capital stock is divided is forty (40) of the

par value of Five (\$5.00) Dollars.

Seventh: That, pursuant to three days' public notice in a newspaper published in the county of Greenville, at a meeting of the subscribers held on January 8, 1943 at which a majority of all stock in value being present in person or by proxy, the following were elected directors:

Naomi Sloan, Raymond Barton, L. T. Robertson, Ophelia Meekins, Gary Drake, LeRoy Smith and Samuel Blythe.

Eighth: That subsequently there was elected as President, Naomi Sloan; as Vice-President, Raymond Barton; as Secretary, L. T. Robertson; as Treasurer, Ophelia Meekings.

Ninth: That all requirements of Chapter 158, Article I, of the Civil Code of South Carolina, 1942, and all amendments thereto, have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, and 20 per cent. of the capital stock subscribed having been paid to the Treasurer.

now, THEREFORE, I, W. P. Blackwell, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
