Thompson on 3 sides and other lands across new road of the Lessors, for the term of one year, from the 17th day of March 1944 and the said Ressee in consideration of the use of said premises for the said term, promise to may the said lassor the sum of Five (\$5.00) Dollars per week payable in advance to J. D. Robins at his office in the Palmetto Building, Greenville, S. C. After the Lessee pays as much as \$200 tenis to have the option of purchasing the property at the price of \$1000, and after paying as much as \$400 he is to get deed to the property and give mortgage over the premises to the owners for \$600 at 6% percent interest for a period of  $2\frac{1}{2}$  years.
