on waters of Reedy Fork Creek containing twenty and one-half (20 $\frac{1}{2}$) acres, more or less, having the following metes and bounds:

Beginning on a stone in road thence S. 22 $\frac{1}{2}$ W. 18.87 chains to a stone; thence S. 70 $\frac{1}{2}$ E. 14.70 to a stone in branch; thence up branch 9.75 to stone on branch; thence N. 25 E. 4.42 to stone; thence S. 82 $\frac{1}{2}$ W. 12.16 to stone; thence N. 5 3/4 E. 11.15 to a pin in ditch; thence S. 88 W. 2.78 to the beginning corner, adjoining lands of T.
