DEED OF CONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That we, F. F. Holland, Mrs. Sylvia H. Kilgore, Mrs. Eunice H. Hughes, Mrs. Vida H. Kilgore, Mrs. Nannie C. Holland and Annie Ruth Holland, all residents of the State of South Carolina, in consideration of the sum of One Thousand Dollars to us paid by Charles L. King in the State and County aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charles L. King, his heirs and assigns.
