TITLE TO REAL ESTATE

Pike, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell, and release unto the said D. Z. Pike, his heirs and assigns, forever:

All that piece, parcel or lot of land in the State of South Carolina, County of Greenville, North of the City of Greenville, in the Subdivision known as Riverside Farms, and being known and designated as the Eastern portion of Lot No. 41 of Riverside Farms according to a plat thereof made by P. H. Foster in August, 1907, and being more particularly described as follows:-

Beginning at an iron pin at the Northwest corner of the intersection of Haynsworth Road (formerly known as the extension of Edgemont Avenue) and a 25 feet road and running thence with said 25 foot road in a Northeasterly direction 400 feet to corner of Lot No. 42; thence with line of Lot No. 42 N. 44-14 W. 260.25 feet to a point, corner of that portion of lot No. 41 conveyed to D.
