A. Roe, all that certain lot of land, with the improvements thereon, situate in the City of Greenville, County of Greenville, State of South Carolina, on the Eastern side of South Laurens Street, in the Block between W. McBee Ave. and West Washington Streets, and having, according to a plat thereof prepared by C. M. Furman, Jr., Engineer, October 23, 1929, the following courses and distances, to-wit:-
