B. Jones all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina and County of Greenville, a short distance south of the City of Greenville, opposite Tanglewood School House, known and designated as Lot number two (2) of Hoke's subdivision, as shown on Wm. D. Neves's plat dated Dec. 1, 1912, and recorded in the office of the Register of Mesne Conveyances for said county in Plat Book "C", page 54, and having, according to said plat, the following metes and bounds, towit: Beginning at a stake on the east corner of Pendleton Road (sometimes called the "Saluda Dam Road") and Sturdevant Street, and running thence with said Pendleton Road S. 56 E. one hundred (100) feet to a stake on the corner of Lot No. 1; thence N. 34 E. 405 feet along line of Lot No. 1 to a stake on First Street; thence N. 56 W. with First Street 100 feet to a stake on the corner of Sturdevant Street; thence S. 34 W. with Sturdevant Street four hundred and five (\$405) feet to the beginning corner.
