BEGINNING at an iron pin on the North side of South Main Street at the center of a sixteen inch brick wall, which point is 100.1 feet in a westerly direction from Northwest corner of the intersection of South Main Street and Hammond Street, and running thence N. 36° 47 W. with the center of said sixteen inch brick wall, and beyond same 150 feet to an iron pin on the South side of Chicora Street, which point is 100 feet in a Westerly direction from the Southwest corner of the intersection of Chicora Street and Hammond Street, thence with Chicora Street, S. 61° W. 25 feet to an iron pin; thence S. 36° 38 E. to and through the center of a sixteen inch brick wall 156.3 feet to an iron pin on the North side of South Main Street; thence in an Easterly direction with the line of South Main Street, 25 feet to the point of beginning, and being known as Lots Nos. 5 and 38 on a plat of the property of Thos.
