Beginning at an iron pin on the Southern side of Croft Street, 350 feet east from Townes Street, and running thence with the southern side of said Street, S. 83-25 E. 50 feet to an iron pin; thence S. 6-35 W. 187 feet to an iron pin; thence N. 83-25 W. 1.3 feet to iron pin; thence S. 6-35 W. 28 feet to iron pin; thence N. 83-25 W. 48.7 feet to iron pin; thence N. 6-35 E. 215.7 feet to the beginning corner."
