## TITLE TO REAL ESTATE

WHEREAS, on the 15th day of January, 1926, in consideration of the sum of Fifty-eight hundred and fifty and no/100 Dollars, (\$5,850.00), Thirty three hundred and fifty and no/100 Dollars, (\$3,350.00), being paid by Miss Sarah Little, and Twenty-five hundred and no/100 Dollars, (\$2,500.00), being paid by Miss Maggie Little, the American Bank, of Greenville, S. C., assigned, transferred and set over unto the said Misses Sarah & Maggie Little the said real estate mortgage as more fully appears on the said record in Real Estate Mortgage Book 63 at page 121, in the Office of the R. M. C. for Greenville County, S. C.

WHEREAS, on the 12th day of May, 1937, J. E. Lipscomb, as administrator of the Estate of Miss Maggie Little, did assign, transfer and set over unto the estate of Alice J. Gunn, in consideration of the sum of twenty-five hundred and no/100 Dollars, (\$2,500.00), all the interest in this mortgage owned by the estate of Alice J. Gunn, which interest was a 2500/5850 undivided interest in said mortgage.

WHEREAS, on the 17th day of March, 1941, the said Florence R. Jacobi, by her deed, did convey to Miss Sarah Little & to J. E. Lipscomb, Jr., M. L. Gunn, Alice Gertrude Lipscomb, as Trustees of the Estate of Alice J. Gunn, the property covered by said mortgage in full satisfaction of the said mortgage in the amount of Fifty eight hundred and fifty and no/100 Dollars, (\$5,850.00).

E. Lipscomb, Jr., M. L. Gunn, Alice Gertrude Lipscomb, as Trustees for the Estate of Alice J. Gunn.
