GENERAL POWER OF ATTORNEY

FURTHER, I do authorize my aforesaid attorney-in-fact to perfrom all necessary acts in the execution of the aforesaid authorizations and generally to do any and all acts on my behalf on any other matter or thing pertaining or belonging to me with the same vaildity as I could effect, if personally persent; hereby ratifying and confirming whatsoever my said attorney shall and may do, by virtue hereof, in the premises; including power to sign my name on any document requiring same, with full force and effect and with the same validity as I could effect if personally present.

This general power of attorney shall be liberally construed, and its general terms shall not be limited by any specific acts.

FURTHER, this power of attorney shall remain in full force and effect until revoked by me.
