Lots 102-103: Beginning at a point on South side of New Easley Highway at the intersection of said Highway and Carlton Ave. and running thence along New Easley Hwy. S. 87-56 W. 75 feet to corner of lot #101; thence N. 2-04 E. 116 ft. to point on Carlton Ave.; thence along Carlton Ave. N. 35-00 E. 87 $\frac{1}{2}$ ft.; thence continuing along Carlton Ave. N. 27-30 E. 50 $\frac{1}{2}$ ft. to beginning corner; being the same property conveyed to grantor by Fallis Realty Co. by deed dated March 26, 1935, recorded in Vol. 172, at page 176.

Lots: Nos. 98, 99, 100 & 101: Beginning at joint corner of lots 102 & 101, which point is 75 feet from the intersection of Carlton Ave. and Saluda Dam Road, and also corner of lot herebefore conveyed to Frank Fazio and running thence along Easley Highway in a Westerly direction 100 ft. to corner of lot #97; thence with line of lot 97 S. 2-04 E. 148.2 ft. to point in line of lot #104; thence with line of lot No. 104 in an easterly direction 75 feet to point on Carlton Ave.; thence along Carlton Ave. N. 35 E. 41.1 feet to corner of lot No. 102; thence with line of lot 102 N. 2-04 W. 116 ft. to beginning corner on Easley Highway. Being the same property conveyed to grantor by Fallis Realty Co. by deed dated June 26, 1936, recorded in Vol. 185, page 41.
