(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said
W. F. Nabors and R. L. Bridges, share and share alike, their heirs and assigns:

All that piece, parcel or lot of land in Township Greenville County, State of South Carolina

All that tract of land situate on the west side of the old Buncombe Road, some four or five miles from the Greenville County Court House in the County and State aforesaid, and more particularly described as follows:

Beginning at a point on the west side of the said Old Buncombe Road which point is the joint corner of this land and that already belonging to W. F. Nabors, and runs thence N. 6-06 E. 187.5 feet; thence N. 0-10 E. 557 feet to an iron pin, in or near said Old Buncombe Road; thence N. 79-30 W. 762.8 feet to an iron pin; thence due west 1975.5 feet to a stake; thence S. 32-10 W. 1013 feet along Watkins' line to an iron pin; thence S. 21-45 W. 622.4 feet crossing the G. & N. Railway and right-of-way to Mulberry Stump; thence S. 36-15 W. 250.8 feet crossing Reedy River as it now runs to a point in the old run of said river; thence along the meanders of the old run of said river as a line 363 feet to a point at the mouth of a branch, which point is at the conjunction of the said old run and the present Reedy River; thence up the meanderings of said branch as a line to corner in Minor Wynn's Spring; thence N. 67-45 E. 415.8 feet to a stone; thence N. 79-45 E. 330 feet to a stake; thence S. 51 E. 330 feet to a stone; thence S. 80-05 E. 452 feet to the beginning corner, containing 66.50 acres, more or less; subject however, to the right-of-way of the said G. & N. Railway and any and all rights-of-way for water, sewer, lights, telephone or power lines that now cross or occupy any portion of said land.
