Cartee, Plaintiffs on or about the 16th day of September in the year one thousand nine hundred and Forty Three did exhibit their complaint in the Court of Common Pleas in the County of Pickens and State aforesaid praying that the Court do confirm the sales of tract 1 and 2 as herein alleged, that it do order the sale of tract 3 and 4 at public auction, executing proper titles therefor, and that the proceeds of the entire sales be divided among the heirs as entitled, and for such other and further relief as is just and proper. All as set out in Judgment Roll No. 6299, Pickens County, South Carolina records.

D. Grant for Eleven Hundred Five and no/100's (\$1105.00) Dollars being, at that price, the highest bidder for the same.

NOW, KNOW ALL MEN, That I, the said E. P. McDaniel, Clerk of Court in consideration of the premises, and also in consideration of the sum of Eleven Hundred Five and no/100's (\$1105.00) Dollars paid me by the said H. D. Grant, the receipt whereof is hereby acknowledged, HAVE granted, bargained, sold and released, and by these Presents, DO grant, bargain, sell and release unto the said H. D. Grant and his Heirs and Assigns,

"All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in the City of Greenville, Beginning at an iron pin on the west side of Mulberry Street about Two Hundred Six (206) feet from Buncombe Street, and having a frontage of Fifty (50) feet on Mulberry Street, more or less, and a depth of Two Hundred Ten (210) feet, more or less, and upon which there is a five room cottage, conveyed to G. E. Smith by A. H. Dean by deed dated August 16, 1915, and recorded in Book II at page 635, and conveyed from Mary J. Cartledge to P. C. Cartee by deed dated November 1, 1919, and recorded in Book of Deeds 56 at page 171, in the office of the Clerk of Court for Greenville County, South Carolina."
