DECREE OF DIVORCE.

THIS CAUSE, coming on to be heard at this Term was submitted upon the Bill of Complaint, decree pro confesso, and testimony as noted by Register, and, upon consideration thereof, the Court is of the opinion that the Complainant is entitled to the relief prayed for in her said bill.

It is therefore ordered, adjudged and decreed by the Court, that the bonds of matrimony heretofore existing between the Complainant and Defendant be, and the same are hereby dissolved, and the said Florence L. McPherson is forever divorced from the said Robert McPherson for and on account of voluntary abandonment of the bed and board of the complainant by the Respondent for two years next preceding the filing of the bill, as alleged in said Bill of Complaint.

It is further ordered that the said Florence L. McPherson be, and she is hereby, permitted to again contract marriage, upon the payment of the costs of court in this cause.

It is further ordered, that the said Robert McPherson pay the costs herein taxed, for which execution may issue, and if such execution is returned "no property found" then execution for costs may issue against the said Florence L. McPherson.

It is further ordered, adjudged and decreed, that said Florence L. McPherson shall not marry again except to said Robert McPherson until sixty days after this date, and if an appeal is taken within sixty days she shall not marry again except to said Robert McPherson during the pendency of said appeal

It is further ordered that execution for costs be stayed sixty days. This 23rd day of March, 1928.
