Investment Co. property; thence S. 39-33 E. 30 feet to an iron pin; thence across the rear portion of Lot No. 25, of Block B, of Augusta Court, S. 55-30 W. 60 feet to an iron pin; thence N. 39-33 W. 30 feet to an iron pin in the rear line of Lot No. 17; thence along the rear line of Lot No. 17 and 16, N. 55-30 E. 60 feet to the beginning corner.
