Beginning on a stone NM on corner of above tract and running thence N. 22-3/4 E. 19.30 to stone on; thence N. 35-3/4 W. 15.60 to small hickory 3xom; thence S. 38 $\frac{1}{2}$ W. 21.80 to stone on; thence S. 42 $\frac{1}{2}$ E. 19.40 to the beginning corner.
