In general to do all other acts, deeds, matters, and things whatsoever in or about my estate, property, and affairs, or to concur with persons jointly interested with myself therein in doing all acts, deeds, matters, and things herein, either particularly or generally described, as fully and effectually to all intents and purposes as I could do in my own proper person if personally present.

Wofford, or any attorney by them hereunder substituted, shall lawfully do or cause to be done in and about the premises by virtue of these presents, including anything which shall be done between the revocation of these presents by my death or in any other manner and notice of such revocation reaching my attorneys; and I hereby declare that as against me and all persons claiming under me everything which my attorneys shall do or cause to be done in pursuance hereof after such revocation as aforesaid shall be valid and effectual in favor of any person claiming the benefit thereof who before the doing thereof shall not have had notice of such revocation.

My attorneys above named shall not be held personally responsible for any loss, damage or injury, which I may suffer on account of the failure of any bank wherein money is deposited by them for me as my attorneys, or on account of any other act, deed, or authority exercised by them for me under this Power of Attorney.
