than 21% on Lessee's such gross sales during the term of any renewal of this lease.

41. This lease shall be binding upon the respective Lessors and their respective heirs, administrators, executors or assigns, and upon the Lessee, its successors and/or assigns.

42. For-the-purpose-of-public-record, -the-parties-to-this-lease-have, -at-the-same-time;-executed-a-shert-form-lease-for-recording;-and-beth-the-Lessers-and-the-Lesses-agreethat-they-have-not-dene-and-will-not-de-anything-inconsistent-with-this-lease--

43. The Lessors agree to take out and keep fire insurance on the building or buildings in the sum of 100% of the insurable value of the buildings, in a reliable stock insurance company or companies, with extended coverage, if possible, but should the Lessors fail to do this at any time during the term of this lease, the Lessee shall not only have the right to take out such insurance up to 100% of the insurable value of said building or buildings, in the name of the Lessors, as their interests appear, and deduct any preimums paid on same from any rents owing to the Lessors, but it shall be the Lessee's duty to do so, and regardless of anything to the contrary herein, neither the Lessors nor the Lessee shall have any right of action against the other for failure to take out and keep fire insurance on the building in force; and, regardless of anything to the contrary herein, neither the Lessors nor the Lessee shall owe any duty to repair or restore the building after fire or other casualty beyond Lessee's control, except when fire insurance moneys are available for such purpose.

14. This lease shall be governed by the laws of South Carolina.
