TITLE TO REAL ESTATE

State of South Carolina, County of Greenville.

This Agreement made and entered into at Greenville, S. C. this 26th day of March, 1945, by and between J. S. Watson, hereinafter designated as the Seller and Lee Henderson, hereinafter designated as the purchaser, Witnesseth:

The Seller agrees to sell and does hereby sell unto the purchasers the property hereinafter described at and for the consideration hereinafter stated.

The purchaser agrees to purchase and does hereby purchase said property and agrees to pay unto the seller as the purchase price therefor the sum of twelve hundred fifty dollars, (\$1250.00). Five hundred and no/100 (\$500.00) Dollars to be paid upon the signing of these presents and the balance to be paid in amual installments of \$100.00 each, and a final installment of fifty dollars. Said yearly installments to be paid on the 26th day of March of each succeeding year hereafter. The deferred portion of the purchase price to bear interest at the rate of six per cent (6%) per annum, payable annually.

Upon default by the purchaser in payment of said annual installments or interest, the within contract shall terminate and all interest of the purchaser in said property shall cease. Whereupon the seller shall have the right to re-enter possession of said premises and retain the amounts so paid on the within contract as liquidated damages.

Upon payment of said purchase price by the purchaser, the seller hereby binds and obligates himself, his heirs, executors or Administrators to execute unto the purchaser a good and sufficent deed conveying said property to the purchaser free and clear of liens and encumberances with dower renounced thereon.

The parties here to bind themselves to the full performance of all terms and conditions contained herein.
