		Together with the right of enjoyment of privileges and facilities afforded by Lake Lanier
7		an artificial water, as projected on said plat, for lawful aquatic sports, boating, bathing, swim
1		ming and fishing, and together with the further right to erect for the use of the owner of the
10		above described lot a boat house and wharf or landing at some appropriate location on the margin
502		of said Lake, the said location and the size, plans and specifications of said boat house and
٦		wharf or landing to be subject to approval of grantor; but nothing herein contained shall privile
-		a nuisance or license the pollution of the said Lake, its inlets, outlets, or beaches, nor
┢		authorize any unlawful, offensive or boisterous conduct, or the use of the said Lake by any per-

ŀ		holders or successors, shall not be liable to any lot owner or any other person for any damage or

		term of twenty-one years from date hereof, subdivide, sell or convey any part or parcel of said
		lots, less than the whole of each thereof, as shown on said plat (the grantor hereby expressly
		reserving the right, however, to sell and convey any part of parcel of any lot within said block,
-		in connection and merged with any adjoining lot, so as to create one or more lots of larger area
		than as shown on said plat, and the further right to determine the size and shape of lots sold
		for other than residential purposes.)
		5. That the grantor herein reserves the right to lay, erect and maintain, or authorize
		the laying, erecting and maintaining of sewer, gas, and water pipes, electric conduits or pipes,
		telegraph, telephone and electric light poles, and any other such public utilities, on or in any
		of the roadways, streets or alleys bordering said property, with connecting links for the same
		along the back and side lines of the lot above described, and to grade surface, and repair the
		said roadways, streets and alleys, without compensation to any lot owner for any damage sustained
