POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That , I , Thomas L. C., my true and lawful attorney to act in, manage, and conduct all my estate and all my affairs, and for that purpose for may and in my name, place, and stead, and for my use and benefit , and as my act and deed, to do and execute, or to concur with persons jointly interested with myself therein in the doing or executing of all or any of the following acts, deeds, and things, that is to say:

(1) To buy, receive, lease, accept, or otherwise acquire; to sell, convey, mortgage hypo thecate, pledge, quit claim, or otherwise encumber or dispose of; or to contract or agree for the acquisition, disposal or encumbrance of; any property whatsoever and wheresoever situated, be it real, personal, or mixed, orany custody, possession, interest, or gight therein or pertain ing thereto, upon such terms as my said attorney shall think proper; (2) to take, hold, possess invest, lease, or let or otherwise manage any or all of my real, personal, ommixed property, or any interest therein; to eject, move, or relieve tenants or other persons from, and recover posesion of, such property by all lawful means; and to maintain, protect, deserve, insure, remove, store, transport, repair, rebuild, modity, or improve the same or any part thereof; (3) To make, do, and transact all and every kind of business of what nature or kind soever, including the receipt, recovery, collection, payment, compromise, settlement, and adjustment of all accounts, legacies, bequests, interests, dividends, annuities, demands, debts, taxes, and obligations, which may now or hereafter be due, owing, or payable by me or to me; (4) To make, indorse, accept, receive, sign, seal, execute, acknowldege, and deliver deeds, assignments, agreements, certifica tes, hypothecations, checks, notes, bonds, vouchers, receipts, and such other instruments in writ -ing of whatever kind and nature as may be necessary, convenient, or proper in the premises; (5) either my said attorney's name or my name or jointly in both our To deposit and withdraw for the purposes hereof, in/names, in or from any banking institution, any funds, negotiable paper, or moneys which may come into my said attorney's hands as such attorney or which I now or hereafter may have on deposit or be entitled to; (6) To institute, prosecute, defend, compromise, arbitrate, and dispose of legal, equitable, or administrative hearings, actions, suits, attachments, arrests, distresses or other proceedings, or otherwise engage in litigation in connection with the premises; (7) To act as my attorney or proxy in respect shares, bonds, or other investments, rights or interests, I may now or hereafter hold; (8) To engage and dismiss agents, counsel, and employees, and to appoint and remove at pleasure any sub stitute for, or agent of my said attorney, in respect to all or any of the matters or things herein mentioned and upon such terms as my attorney shall think fit; (9) To execute vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States, including but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law or Army regulations, and to receive, indorse, and collect the proceeds of checks payable to the order of the undersigned drawn on the Treasurer of the United States; (10) To prepare, execute, and file income and other tax returns and other governmental reports, applications, requests and documents; (11) To take possession, and order the removal and shipment of any of my property from any post, warehouse, depot, dock, or other place of storage or safe keeping, governmental or private; and to execute and deliver any release, voucher, receipt, shipping ticket, certificate, or other instrument necess ary or convenient for such purpose.
